	<ul> <li>You must pay the additional amount due if the check amount does not cover the total tax due.</li> </ul>

	<ul> <li>By March 31st of each year, you must send a copy of the paid receipt to us at the address above or by emailing it to <u>customercare@bsifinancial.com</u>, ATTN: WI OPTION 1 TAX RECEIPT/ [loan#].</li> </ul>
	<b>Failure to Comply:</b> If you fail to send a copy of the receipt to us by March 31st or the loan is not current on December 17th, you will lose the right to have the check sent directly to you for that year's tax payment. We will make the tax payment directly to the town, city, or village taxing authority as described below in Option 2.
